- Immorality accumulate in each country, which can slowly degrade the faith and taqwa in the aggregate.


So, it is necessary for formulating and finding a solution to the problem of takaful ijtima'i in increasing faith and taqwa in Muslim communities aggregately.




Figure 1. Analytical framework Source: Rizma Riyandi Rahman


# Application of maqashid al-shari'ah in Takaful ljtima'i

Life/Soul (nafs)	<ul> <li>Provision of health facilities:         hospitals, health centers.</li> <li>Assurance of food and residence.</li> <li>Security and peace (police, national army)</li> </ul>
Intellect (Al-Aql)	Assurance of education without boundaries (elementary, junior high school, high school, university)
Lineage (Nasl)	<ul> <li>Warranty to childbirth -means of delivery-</li> <li>Guarantee thoroughbred indefinitely (annihilation program of contraceptive device)</li> <li>Eradication of adultery/prostitution activities</li> </ul>
Property (Al-Mal)	Ensure availability of jobs and business

# Analysis of the concept of I-Mq'S (Iman-Maqashid al-Shari'ah) in Achieving Welfare




Figure 2. Correlation analysis I-Mq'S to the welfare Source: Rizma Riyandi Rahman
